If you receive a notice, you will be provided a deadline to address the violation. We understand some issues may take longer to resolve, so please communicate any obstacle to comply to the HOA promptly - in writing - to avoid violation fines and/or special assessments. All residents must be approved by the HOA Architectural Control Committee (ACC) for any exterior changes PRIOR to starting any exterior project. The ACC Architectural Review Application form is available to download on our website.
